The Key is Responsible Sourcing

Packaging made from forest-fibre has the potential to be both renewable, recyclable and biodegradable, but only when it is responsibly sourced.

FSC certification ensures that forest-based materials, such as paper and packaging, are procured from forests adhering to stringent environmental and social criteria.

When companies in the paper, printing, and packaging sector choose FSC-certified materials, they actively support the preservation of biodiversity, uphold Indigenous rights, and contribute to the conservation of crucial ecosystems.

FSC Certification

Who Needs Certification?

Any company involved in the transformation, processing, manufacturing or distribution of a forest-based product, must be FSC certified in order to apply an FSC label to their products and/or sell them with an FSC claim.

This includes, but is not limited to:

- → Pulp Mills
- → Paper Mills
- → Paper Merchants
- → Paper Converters
- → Printing Companies
- → Print Brokers (That Take Legal Possession)

How Does It Work?

FSC Certification takes place through independent third-party assessments by Certification Bodies.

Certifiers will audit your business to ensure that:

- → You are purchasing FSC certified products from a certified supplier
- Certified products are clearly identifiable
- Certified products are separated from non-certified
- Certified products are traceable, and volumes are recorded
- → You have a good management in place

What Do the Labels Mean?

Found on thousands of products labels around the world, the FSC labels provide assurance that the material or product comes from verified and responsible sources that have met FSC's strict environmental and social requirements.



FSC 100% products made from 100% virgin material from FSC-certified forests.



FSC Mix products which are made from FSC virgin fibre, and/or recycled materials with controlled virgin fibre.



FSC Recycled products which are made with 100% recycled fibre.

5 Steps to FSC Certification

- Contact a certification body: Contact one, or several, third party certification bodies who will provide a cost estimate and timeline. The certification body will provide you with information about the requirements for FSC certification.
- Application & agreement: When you decide which certification body you would like to work with, fill out an application form and sign an agreement with the certification body.
- Complete an on-site audit: Complete an on-site certification audit where your selected certification body will assess your company's qualifications for certification.
- Certification approval: The data collected during the audit will be captured in an audit report. The certification body will make a certification decision based on the information in the report.
- Annual audit: The certification body will also conduct annual surveillance audits to verify your continued compliance with FSC certification requirements. FSC certificates are valid for five years.

Consumer Confidence

FSC certification is a globally recognized label that instills confidence in consumers. Research has found that 80% of consumers who recognize FSC, say they are more likely to trust a brand if it offered FSC-certified products (Ipsos 2023).

Brand Reputation and Loyalty

FSC certification enhances a company's reputation by showcasing a commitment to sustainability and responsible business practices.

Supply Chain Transparency

Certification provides a clear chain of custody, ensuring that products can be traced back to responsibly managed sources, mitigating the risk of unknowingly using illegal or unsustainable materials.

Competitive Advantage

Certification signals to consumers that your company is committed to responsible sourcing and manufacturing, providing a competitive edge.



Consumers Trust FSC to Protect Forests

Consumers are increasingly aware of rising global issues such as forest and wildlife loss and its contribution to climate change.

They expect change from the paper & packaging industry, especially avoiding single-use packaging by looking for more sustainable solutions.

In this context, specifying FSC-certified materials and asking suppliers to apply an FSC label gives consumers the assurance that a business has chosen to source materials responsibly.

- 66% of consumers expect companies to ensure that the wood/ paper products and packaging they sell are not contributing to deforestation.
- → 63% of consumers try to buy products packaged with renewable materials such as paper instead of plastic.
- → 8 in 10 consumers who recognize the FSC label say they are more likely to trust a brand if it offered FSC-certified products.
- Over three quarters of consumers (77%) show moderate to high levels of confidence in FSC to protect forests. Compared to other types of organizations, consumers have the highest confidence in FSC, which is considerably higher than businesses* or governments.
